- work in professional and interpersonal contexts, collaborating in work groups in a critical and proactive manner.

<p>Entry requirements Lower secondary school leaving diploma.</p> <p>Additional information Yearly school hours are divided into mandatory subjects and activities and optional subjects if provided for in the Educational Plan drawn up by each school. Schools can allocate a percentage of the total hours of the national study plans (up to 20% in the first two years, 30% in the third and fourth years and 20% in the fifth year) to tailor curricula to local needs. Schools can set up a scientific committee made up of teachers and work experts. During the 5th year, a non-language-related subject is taught in a foreign language. Activities and modules related to "Citizenship and Constitution" are envisaged in the historical-geographical and historical-social fields.</p>
